Sealed Bids for the Willeke Avenue Reconstruction Phase 1 will be received by the Village of Ada at the Village Office, 115 W. Buckeye Avenue, Ada, OH 45810, until Tuesday, January 30, 2018 at 10:00 a.m. local time, at which time bids received will be publicly opened and read.

In general, the project consists of the reconstruction of Orders Avenue, Willeke Avenue, and Ankerman Street, including the installation of storm sewer, sanitary sewer, water main, and service laterals.

A non-mandatory Pre-Bid conference will be held at 10:00 a.m. local time on Wednesday, January 24, 2018 at the Village of Ada, Village Office, 115 W. Buckeye Avenue, Ada, OH 45810. Representatives of Owner and Engineer will be present to discuss the Project. Bidders are encouraged to attend and participate in the conference. Engineer will transmit to all prospective Bidders of record such Addenda as Engineer considers necessary in response to questions arising at the conference. Oral statements may not be relied upon and will not be binding or legally effective.

Bids must be signed and submitted on the separate bidding forms and sealed in a properly identified envelope.

The bid security shall be furnished in accordance with Instructions to Bidders.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the Equal Employment Opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

DOMESTIC STEEL USE REQUIREMENTS AS SPECIFIED IN SECTION 153.011 OF THE REVISED CODE APPLY TO THIS PROJECT. COPIES OF SECTION 153.011 OF THE REVISED CODE CAN BE OBTAINED FROM ANY OF THE OFFICES OF THE DEPARTMENT OF ADMINISTRATIVE SERVICES.

Bidder must comply with the prevailing wage rates on Public Improvements in Hardin County and the Village of Ada, Ohio as determined by the Ohio Bureau of Employment Services, Wage and Hour Division, (614) 644-2239.

No Bidder shall withdraw his Bid within 60 days after the actual opening thereof.

The Owner reserves the right to reject any or all Bids, waive irregularities in any Bid, and to accept any Bid which is deemed by Owner to be most favorable to the Owner.
